# Downloading of e-PPO, e-GPO and e-CPO

## As a transformation under **5T initiative** of Govt. of Odisha

- ▶ Controller of Accounts have been issuing all **Pensionary benefits** through Electronic mode from **1st of April 2021** i.e **e-PPO, e-GPO** and **e-CPO vide FDOM 1923 Dt-19/01/2021**. Now **e-Intimation letter** for Treasury is also being uploaded in **<http://odishatreasury.gov.in> w.e.f 05/07/2021**.
- ▶ All orders uploaded in **<http://odishatreasury.gov.in>** will be available in their respective login of **PSA, Treasury** and **Sub-Treasury** on **real time basis**.
- ▶ Descriptive roll and all other related letter i. e. Objection, Cancelation, regarding held up of Gratuity and any other information will be sent through **Hard Copy**.
- ▶ **Pensioners** are intimated through **SMS** and a **downloading** facility of e-Authorities is also being available in **<http://odishatreasury.gov.in> / <http://caodisha.nic.in>**.

# Role and responsibility of HoO and PSA in respect of e-Authroities

- ▶ As soon as e-Authorities are issued and uploaded in the iFMS by the O/o the Controller of Accounts, Odisha, the Pension Sanctioning Authorities(**PSA**) can download/ view the eAuthorities in their respective **login** in IFMS portal.
- ▶ Head of the Office of the retiring pensioner/Family Pensioner where provisional pensionary benefits have been drawn shall prepare the drawal particulars and forward the same to the concerned treasury for facilitating final disbursement.

# Tracking of pension by Pensioner

- ▶ SMS will be sent to the Pensioner after processing of the pension application. The pensioner can download their copies of e-Authorities from the website of Odisha Treasury (<https://odishatreasury.gov.in/portal> ) or **Controller of Accounts** (<http://www.caodisha.nic.in> ) by using their **GPF Account No.** through **OTP** verification.

**(This process is identical to the process of downloading of GPF Account slip )**

# Instruction to PSA

- ▶ Henceforth, immediately after receipt of e-Authority on iFMS portal the PSAs' shall issue "Drawal particulars relating to provisional pensionary benefits" in favour of the pensioner.
- ❑ **They may not wait for receipt of Service BOOK.**
- ❑ **They may not ask for copies of e-Authorities or Intimation letter from the pensioners.**
- ❑ **It is reiterated that intimation letter is not sent or issued to Pensioner.**
- ❑ **Pensioners may not be insisted/compelled to visit the O/o PSA.**
- ❑ **It is the responsibility of the Payable Treasury/ Sub-Treasury to disburse the pension to the right person.**
- ❑ **Pensioner need not apply to PSA for issue of "Drawal Particulars relating to provisional Pensionary benefits".**

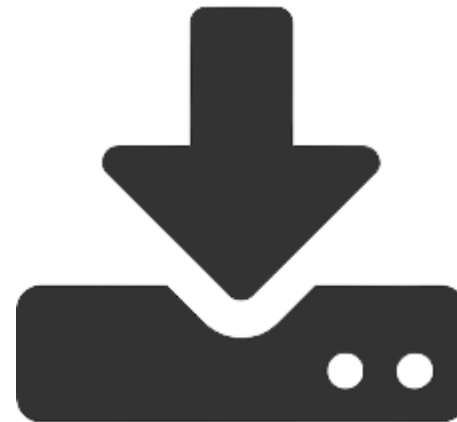

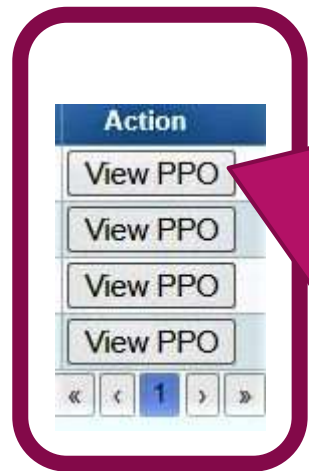

production before the Pension Disbursing Authorities (Treasury Officer) for receiving payments during the interim period of parallel run.

#### Role and responsibility of Treasury Officer:

After authorization of the pension, the Treasury Officer will download the e-Authority in Part-I & II for further processing.

The Treasury Officer will also refer the identification documents and specimen signature of the pensioner physically forwarded by the O/o the Controller of Accounts, Odisha before the final disbursement.

Part-III of the e-PRO will be provided to the pensioner after the payment is completed under the digital ink signature of the Treasury Officer. The pensioner may visit the Treasury to obtain the same after receiving the payment or can download the same from the portal as per link / her convenience.

Since the O/o the Controller of Accounts, Odisha shall not provide the Pension Payment Order (PPO) Book containing PART-I to VI, the Directorate of Treasury & Inspection, Odisha will make necessary arrangement along with software to be made available to the Treasury Officer to provide the print copies of the above forms, if required by the pensioner.

After the first payment is made, the information of such first payments made against each Authority and also Treasury-wise list of first payments, needs to be made available in IPMS to the O/o the Accountant General (AG) and O/o the Controller of Accounts. The same can also be downloaded in excel/zip/pdf format.

Authorities which are not encoded /unpaid) during its validity period may be returned to the O/o the Controller of Accounts for revalidation through mutual correspondence till an electronic facility for such activity is made available. Requirement of any correction in the electronic authority will also be dealt with, for the time being, as per existing practice.

Similarly, when an e-authority is required to be cancelled by the O/o the Controller of Accounts, Odisha, the concerned Treasury Officer shall provide the last payment made against the particular authority and which is not ink "cancelled / closed" on the body of the e-authority and send there to O/o the Controller of Accounts through post for closure / cancellation of the same. While sending such request for cancellation, the Treasury Officer will provide the PPO through an action in IPMS, so that the said PPO cannot be utilized for any further payment.

Regarding timely disbursement of pension e-authorities issued by office of the Controller of Accounts(O).

Re:

The e regarding disbursement of pension and other retirement benefits against the e-PRO, e-GRO and e-CFO issued by Office of the Controller of Accounts. This office has started issuing the e-authorities w.e.f. 01.04.2021 vide Finance Department O.M. No.193 dated 19.03.2021. Till date the office has uploaded 1320 numbers of pension authorities. Almost equal number of e-GRO & e-CFO has been uploaded.

It is learnt from the grievances received from different quarters that pensioners/pensioners are facing lot of difficulties in regard to issue of "Drawal particulars" relating to provisional pensionary benefits in their favour, as hard copies of information letter and PPO etc. are invited by the Pension Sanctioning Authorities in conformity to the proposed Finance Department O.M. thereby making the pensioners run from pillar to post during the difficult time of COVID.

Therefore, I am to request you to kindly organize a virtual meeting with the officials and staff of Pension Sanctioning Authorities (DCOs & SDOs etc.) in presence of officers and technical persons of PA office in phased manner preferably in the week to discuss/resolve on the issues faced at the PA level.

Henceforth, immediately after receipt of e-Authority on FMS portal the following directions may kindly be issued to PSAs to issue "Drawal particulars relating to provisional pensionary benefits" in favour of the pensioners:

- They may not wait for receipt of Service BOOK.
- They may not ask for pensioner's copy.
- Pensioners may not be invited/compelled to visit the O/o PSA
- It is the responsibility of the Payable Treasury to disburse the pension to the right pensioner.
